# Financial services relating to Crypto.com Visa® Prepaid Card

This Financial Services Guide (**FSG**) is provided by FORIS GFS AUSTRALIA PTY LTD (ACN 150 651 004) (**Crypto.com**, **we**, **our** or **us**) to you in relation to our activities (if any) which involve the provision of financial services as defined in the Corporations Act 2001 (Cth) (**Corporations Act**).

This FSG describes our services to assist you to decide whether to use them. It describes how we are remunerated, compensation arrangements, and how we handle any complaints you may have.

#### 1. Our Services

We are a holder of Australian Financial Services License No. 467462 (**AFSL**) issued by the Australian Securities and Investments Commission, under which we can provide certain financial services in connection with the Crypto.com Visa® Prepaid Card, a non-cash payment facility issued by us. We issue the Crypto.com Visa® Prepaid Card in Australia enabling customers to pay for goods and services at retailers which accept Visa cards and withdraw cash through ATMs which accept Visa cards.

We are authorised to provide general financial product advice and deal in a financial product under our AFSL in respect of:

(a) deposit and payment products limited to non-cash payment products.

Any financial product advice we provide will be general in nature and will not take into account your objectives, financial situation or needs. Because of this, before acting on any advice, you should consider its appropriateness having regard to your own circumstances.

Crypto.com's related entities are also involved in the operation of a cryptocurrency exchange platform (**Platform**). The operation of the Platform does not itself constitute a financial service and is not covered by this FSG.

We act on your behalf when we provide the financial services described in this FSG to you.

## 2. How you can give us instructions

You can give instructions to us about our services by contacting us as described in section 7 below.

## 3. How we are paid

None of us, our directors, employees or any of their associates charge for providing the financial services described in this FSG and neither do they receive any remuneration, commission or other benefits in respect of, or attributable to, those financial services. Crypto.com employees will receive a salary and may also receive other benefits based on their performance or the performance of Crypto.com.

Crypto.com receives certain remuneration in connection with the provision of the Crypto.com Visa® Prepaid Card. Additional information about Crypto.com Visa® Prepaid Card is available at: https://crypto.com/au/cards.

### 4. Associations

Our affiliate provides the AUD fiat currency wallet (**Fiat Wallet**) for Platform users in Australia to store AUD funds electronically.

## 5. Professional Indemnity Insurance

Crypto.com has professional indemnity insurance in place that satisfies the requirements for compensation arrangements under section 912B of the Corporations Act 2001, which covers the financial services provided by us.

We are a member of the Australian Financial Complaints Authority, which is an external dispute resolution scheme. If you are not satisfied with the way we respond to a complaint you have about our financial product advice, you are entitled to take your complaint to them.

The Australian Financial Complaints Authority is not able to respond to complaints which relate to other services we provide, such as the operation of our Platform.
