

## CAMPAIGN NOTE

### Crypto Deposit Bonus Giveaway

The Crypto.com entity offering the Crypto.com App in your jurisdiction (“**Crypto.com**”) will conduct the Crypto Bonus Giveaway Campaign (“**Offer**”) according to the following requirements and Official Rules for App Giveaway (“**Official Rules**”). By participating, you (“**Entrant**”) agree to be bound by the Official Rules for Giveaway applicable to your jurisdictions, the terms as set out in this Crypto Deposit Bonus Note and Crypto.com’s applicable terms, including the Crypto.com App Terms and all policies referenced therein. The Offer begins at 14:00 SGT (UTC+8) on 9 March 2026, and ends at 14:00 SGT (UTC+8) on 23 March 2026.

#### 1. How to Enter

To participate in the Offer, you must satisfy the following requirements and comply with all other requirements set out herein in the Official Rules by the end of the Campaign Period to qualify for a chance to get a 5% bonus reward in CRO (“**Reward**”) based on your crypto asset deposits in the [Crypto.com](#) App:

1. Sign up or sign in to the [Crypto.com App \(Guide\)](#)
2. From the [campaign section](#), tap the banner titled **Crypto Deposit Bonus**
3. Under the **Get Started** section, tap **Join now** in Step 1
4. Make at least \$1 in Net Eligible Deposits\*\* (NED) of eligible crypto assets\*\*\*

***\*100 Recipients** will be **randomly** selected at the end of the Campaign Period to win a 5% bonus on their NED (“**Reward**”). Reward is subject to the Official Rules as set out below.*

*\*\*NED is calculated based on your total crypto asset net deposits during the Campaign Period, adjusted for any non-crypto asset flows. NED must be equal to or higher than US\$1, as calculated by Crypto.com in its discretion, in order to qualify for Rewards.*

*\*\*\*Eligible transactions include crypto asset deposits from an external wallet. Eligible cryptoassets include BTC, ETH, XRP, SOL, CRO, LTC, ADA, DOGE, HBAR, XLM, SUI, LINK, TAO, AVAX, ICP, SHIB, WLF, DOT, ONDO, TRUMP, PEPE, FET, VET, DASH, LINEA, BCH, ALGO, XPL, ATOM, PAXG, PUMP, FLR, QNT, RENDER, NEAR, PENGU, SEI, FIL, LION, XAUT. The US dollar value of the deposit will be determined in accordance with Section 2.*

#### 1.1 Additional Exclusions

Notwithstanding the eligibility criteria set out in the Official Rules Clause 1.a below, the following individuals are **also** excluded from entry: (i) users who hold IRA accounts; and (ii) users who are unable to access or use the latest Pay Your Friends feature on [Crypto.com](#) App.

## 2. Reward

### a) Reward Amount.

100 random Eligible Entrants will receive a 5% bonus Reward (paid in CRO) on their NED, within one business day after the Campaign Period ends.

### b) Valuation.

The Reward will be calculated based on the US dollar value of the NED at the time the deposit is made. The CRO/USD exchange rate used to convert the Reward into CRO will reflect a market rate sourced and calculated by Crypto.com at or near the time of distribution, in its reasonable discretion.

### c) Distribution.

CRO rewards will be credited to the qualifying Recipient's Crypto.com App account within one business day after the Campaign Period ends. Distribution is subject to verification of eligibility and compliance with these Official Rules.

## 3. Lock-in Mechanism

### a) Lock-In Period.

There is a one (1) year lock-in period commencing immediately after the Campaign Period ends ("**Lock-In Period**"). Entrants must maintain the locked position in accordance with these Official Rules for the entire Lock-In Period.

### b) Account Balance Requirement.

Throughout the Lock-In Period, Entrants must maintain an account balance in the Crypto.com App at least equal to the "**Eligible Balance**", defined as the sum of: (i) the total eligible deposit amount(s) made during the Campaign Period (NED), and (ii) the corresponding CRO reward credited under this Offer.

### c) Valuation of Account Balance.

For purposes of the Account Balance Requirement, market volatility or price fluctuations alone will not trigger clawback under Section 4.

## 4. Clawback

**a) Triggering Events.**

Clawback of the Reward may be triggered in the following, non-exhaustive scenarios:

- (i) upon withdrawals or other outbound transfers from the Crypto.com App that cause the account balance to fall below the Eligible Balance during the Lock-In Period; or,
- (ii) under any other circumstances involving misuse, rule violations, or bad faith, including, but not limited to, withdrawing funds before the Reward is distributed.

**b) Pro-Rata Clawback.**

If, during the Lock-In Period, the account balance falls below the Eligible Balance due to withdrawals, Crypto.com will apply a pro-rata clawback of the Reward, realized as a fee at the time of the withdrawal.

**c) No Waiver.**

Crypto.com may implement and enforce clawback automatically via the Crypto.com App's fee functionality. Crypto.com's failure to enforce clawback in any instance is not a waiver of its rights.

**Sponsored and Administered by:** The Giveaway subject to these Official Rules is sponsored and administered by the Crypto.com entity offering the Crypto.com App in your jurisdiction.

### 1. Eligibility:

- General Eligibility:** Unless otherwise specified, the Giveaway is open only to persons: (i) who are either: (a) eighteen (18) years of age or older; or (b) such higher age of majority as set by the laws of their jurisdiction, at the time of entry; (ii) who are not residents of Argentina, Austria, Bahrain, Belgium, Brazil, Canada, Germany, Hong Kong, Hungary, Ireland, Israel, Italy, Japan, Kazakhstan, Malta, Mexico, the Netherlands, New Zealand, Poland, Saudi Arabia, Singapore, Sweden, Switzerland or Turkey; (iii) who are not residents of jurisdictions where Crypto.com App is geo restricted, as listed [here](#); and, (iv) who have an active e-mail account and Internet access prior to the beginning of the Campaign Period (defined below). **VOID WHERE PROHIBITED.**
- Individuals Excluded From Entry:** Employees, officers and representatives, and the immediate family members of such employees, officers and representatives (i.e., parent, spouse, siblings, children, grandparents, step-parents, step children and step siblings, and their respective spouses, and those living in the same household, whether or not related) of Crypto.com or its affiliated companies, parent companies, subsidiaries, participating promotional partners, advertising and promotion agencies, webmasters and any company involved in the creation, design, execution, production, or fulfilment of the Giveaway (collectively, the “Giveaway Entities”) are not eligible to enter.

If the Recipient fails to satisfy these conditions within five (5) days of the notice that such person has been selected, that Entrant will not be eligible for the Reward, and an alternate Entrant will be selected, as described in "Entrant Selection and Notification" clause below. **VOID WHERE PROHIBITED.**

**2. No Purchase Necessary.** No purchase or payment of any kind is necessary to enter or participate in this Giveaway.

**3. Acceptance of Rules.** By entering the Giveaway, Entrant: (a) agrees to be bound by these Official Rules and by the interpretation of these Official Rules by Crypto.com and by the decisions of Crypto.com, which are final and binding in all respects; (b) acknowledges compliance with these Official Rules; and (c) agrees to comply with any and all applicable federal, state and local laws, rules and regulations. Winning the Reward (defined below) is contingent upon fulfilling all requirements set forth in these Official Rules. **GIVEAWAY IS VOID WHERE PROHIBITED.**

**4. Campaign Period:** The Giveaway will begin and end on the days and at the times specified by Crypto.com in the campaign details (the "Campaign Period"). Entry methods for the Giveaway will be specified by Crypto.com and all entries must be received during the Campaign Period. Entries must be submitted during the Campaign Period in order to be eligible for the Giveaway. Crypto.com shall have the sole and final decision regarding timekeeping for entry in the Giveaway. Normal time rates, if any, charged by the Entrants' Internet service or mobile provider will apply.

- a. Complete and Truthful Entries. When submitting an entry, Entrant is required to provide complete and truthful information. Entries that are incomplete, illegible, corrupted, false, lost, late or misdirected, deceptive or otherwise not in compliance with the Official Rules may be disqualified from the Giveaway at Crypto.com's sole and absolute discretion. Any trades that are executed through bad trading practices in Crypto.com's absolute opinion, including but not limited to wash trades, false trading, self-dealing, or trades that display any attributes of market manipulation ("Disqualified Trades") will not be counted towards the transaction volume of the participant. Entrant shall abide by all posting and image guidelines as set forth by any social media platform, if any, used to enter into this Giveaway. Crypto.com shall not be liable to any third parties for Entrant's violations of said social media guidelines. Photos displaying or containing profanity or that are obscene or otherwise inappropriate (as determined by Crypto.com) will be disqualified, as will entries that violate copyright laws or infringe on any third party rights. By entering, except where prohibited by law, Entrant is assigning all ownership rights and usage rights to Entrant's photo to the Giveaway Entities.

- d. Number of Entries. Multiple entrants are not permitted to share the same email address. Any attempt by any person to enter the Giveaway more than one (1) time by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Crypto.com and its affiliates, and their respective officers, directors, employees, contractors and agents are not responsible for lost, late, incomplete, invalid, unintelligible or misdirected registrations, which will be disqualified.

**5. Method of Entry:** Entry methods for the Giveaway will be specified by Crypto.com, and all entries must be received during the Campaign Period. Entries must be submitted during the Campaign Period in order to be eligible for the Giveaway.

- a. To enter into the Giveaway, Entrants must, in Entrants must, in addition to meeting the eligibility criteria, satisfy the specific campaign requirements, as specified by Crypto.com, during the Campaign Period (an "**Entry**"). Crypto.com will, in its sole and absolute discretion, determine the validity of each and every Entry, including but not restricted to whether the transaction in question met the requisite level of spending to qualify as an Entry and any exchange rate to be applied with regards to the Entry. **Crypto.com's decision and calculations shall be final and binding on the Entrant.**
- b. Alternative Method of Entry. In addition to any other method specified by Crypto.com to submit an Eligible Entry, Entrants may submit an entry by mail ("Mail-in Entry"). On a plain 3" x 5" card, Entrants must legibly handprint or type the Giveaway name, their name, complete address, city, state, zip code, business or home phone numbers (including area code), and email address. Each envelope is considered one entry. All entries submitted become the sole property of Crypto.com and will not be returned. Crypto.com is not responsible for lost, late, misdirected, illegible, or damaged mailed entries.

Entries must be submitted during the Campaign Period in order to be eligible for the Giveaway.

**6. Rewards:** The item(s) for the giveaway will be specified by Crypto.com (the "Reward"). The total approximate total retail value of the Reward is as specified by Crypto.com. There is a limited number of items for the giveaway and hence the odds of receiving the item for the giveaway will depend on the number of Eligible Entries received during the Campaign Period. Entrants will include participants from the United States and Australia unless otherwise specified by Crypto.com.

- a. Token Reward. Rewards comprising tokens will be issued to the Recipient's Crypto.com App account in the token specified by Crypto.com. Crypto.com will, in its sole and absolute discretion, determine and apply any relevant exchange rate in the calculation of Token Rewards. **Crypto.com's decision and calculations of Token Rewards shall be final and binding**

**on the Entrant.**

- b. **Ticket Reward.** If the Reward includes any ticket(s), it is Recipient's sole responsibility to download the relevant tickets or ticketing app, comply with any additional terms and conditions and complete all procedures relating to receipt of any tickets constituting the Reward or part thereof. - b. Notification of Recipient. The Reward will be awarded to the authorized account holder of the email address of both the Crypto.com App account associated with the entry, selected regardless of the individual who submitted the winning entry. The authorized account holder is the person who is assigned to the Crypto.com App account on Crypto.com’s internal systems. Each potential Recipient will be notified, within thirty (30) days (or such other time specified by Crypto.com) of the end of the Campaign Period, by email (at the email address provided with the entry), by phone (at the phone number provided with the entry), or such other method specified by Crypto.com, and will be required to confirm their email address and/or phone number. Transfer of the Reward will be to the Recipient’s Crypto.com App account made within thirty (30) days of receipt by Crypto.com of the information and documents requested by Crypto.com.
- c. Publicity of Recipient. Additionally, Crypto.com and the Giveaway Entities reserve the right to make a public announcement, announcing the Recipient on either the Crypto.com website, through the Crypto.com App, or in any manner (including, without limitation, social media (e.g., Facebook®, Instagram®, Twitter®, Youtube®)), which they deem appropriate.
- d. Failure of Recipient to Respond to Notification of Selection. If the Recipient cannot be reached after a reasonable effort has been exerted and/or fails to respond to confirm their email address within one (1) day (or such other time specified by Crypto.com) from when the initial notification email is sent, the Recipient forfeits the Reward, and an alternate Recipient will be selected.
- e. Alternative Recipient. If the alternate Recipient does not comply with these Official Rules or is otherwise unable to accept the Reward, the Reward is forfeited and another alternate Recipient will be selected. This Recipient selection and notification process shall be continued until a Recipient is confirmed. If the Reward or a Recipient notification is returned as undeliverable, the Reward will be forfeited and an alternate Recipient will be selected.

**8. Recipient Verification:** The Recipient may be required to prove eligibility, including, without limitation, proof of age, residence, and identity, which may include submitting a copy of his/her passport or similar government issued identification within two (2) hours after being notified of being a potential Recipient.

- a. Official Confirmation of Recipient. The Recipient (or any alternate Recipient if one must be selected) is not official and shall not be confirmed as the Recipient until he/she has provided information and completed, signed and returned all documentation required by Crypto.com, in its sole judgment.
