Holly Jolly Referral Campaign Limited Referral Bonus Offer T&Cs

20 December 2022

1 Introduction

The Holly Jolly Referral Campaign-Limited Referral Bonus Offer (the "**Offer**") described below is sponsored by the entity providing you the Crypto.com App Services referred to as "**Crypto.com**" or "**we**" or "**our**".

The Offer is open for a limited time only, from 23 December 2022, 10:00AM UTC to 9 January 2023, 09:59AM UTC (the "Campaign Period"). The Offer was created to reward existing customers, ("you" or "Referrer") for recommending Crypto.com to their friends and family who successfully sign up, complete the know-your-customer (KYC) application procedures and successfully stake CRO tokens for metal Crypto.com Visa Card ("Referred Customer") (any Referrer and any Referred Customer is a "Participant"). All Participants (both a Referrer and the Referred Customer) must be resident in Australia, Brazil, Belgium, Bulgaria, Canada, Croatia, Cyprus, Czechia, Denmark, Gibraltar, Greece, Hungary, Iceland, Italy, Ireland, Latvia, Lithuania, Luxembourg, Malta, Philippines, Poland, Portugal, Romania, Slovakia, Slovenia, Singapore, Sweden, Taiwan, or the United States (each an "Eligible Region") (as determined by Crypto.com in its sole and absolute discretion) to be eligible for this Offer.

The following Offer Terms and Conditions ("**Terms**" or "**Offer Terms and Conditions**") contains important information about the Offer, so please read these carefully.

These Offer Terms and Conditions shall form part of and are incorporated into the Crypto.com App Terms and Conditions that you agree to when you sign up to the Crypto.com App Services. Capitalized terms not defined herein shall refer to those defined terms in the Crypto.com App Terms and Conditions.

These Offer Terms and Conditions are a binding agreement between you and Crypto.com and will govern your participation in all Offer offers. By participating in the Offer, you agree to and are bound by these Offer Terms and Conditions, including any modifications of these Terms by Crypto.com. By referring a friend, you will be deemed to have accepted and be bound by these Terms and Conditions. The Offer Terms and Conditions apply together with the Crypto.Com App Terms and Conditions, which you accepted when you created a Crypto.com App account.

We may update these Terms from time to time, and if we do, we will not send you a separate notice.

Crypto.com may, in its sole and exclusive discretion, change, cancel, suspend, or modify any aspect of the Offer and/or your participation in the Offer in case of breach of these Terms and/ or where you have acted inconsistently with the intent of these Terms, without notice for any reason and at any time.

Crypto.com reserves the right to disqualify any customers or prospective customers, including any Referred Customer, at any time from participation in the Offer at its sole discretion.

2 Definitions and Interpretation

Unless stated otherwise, capitalised words in these Terms have the same meaning as in Crypto.Com App Terms and Conditions. The following defined terms have the meanings set out below.

"Active Account" means a successfully verified Crypto.com App account where the KYC process has been completed and the Account Holder has staked the required CRO tokens for a metal Crypto.com Visa Card (Ruby Steel tier or above).

"Eligible Transaction" means any valid transaction that has been initiated and complies with these Terms which may allow you to be eligible to receive the Referral Bonus, and that has not been subsequently cancelled. For the avoidance of doubt, Eligible Transactions for this Offer refers to a metal Crypto.com Visa Card staking transaction.

"Prohibited Activities" means the activities set out in Section 6 of these Terms, or any other activities not permitted under these Terms, or any activities that may be disclosed to the Referrer from time to time.

"Referral Code" means a unique number or a combination of numbers and letters assigned to your Crypto.com App account. You can use this code to refer your friends and relatives to Crypto.com. You can give this code to your friends and relatives to be entered manually when they create their Crypto.com App account or upon their first transaction after becoming a new customer.

"Referral Bonus" means the USD 50 payable by Crypto.com to each of the Referrer and the Referred Customer upon the Referred Customer completing all necessary steps required to obtain the Referral Bonus. Pursuant to Section 4 of these Terms, Crypto.com reserves the right to change the Referral Bonus amount at its sole discretion at any time without any obligation on the part of Crypto.com to give notice to you. For your information, the Referral Bonus may be displayed in the Crypto.com App, for example on a page labelled "Referral Bonus".

"Referred Customer" means a new customer who was referred by a Referrer to the Offer using the Referral Code provided by Referrer, has successfully registered a Crypto.com App account in accordance with the Crypto.com App Terms and Conditions and who has successfully completed an Eligible Transaction(s).

3 Referrals

- **3.1. Crypto.com's Sole Discretion.** The Referrer acknowledges and agrees that Crypto.com may, in its sole discretion, decide whether or not to onboard any new customer(s) referred by the Referrer, as well as decide whether such new customer(s) will be considered a Referred Customer(s).
- **3.2. Participation Criteria.** To participate in the Offer, you need to meet the following criteria:
- (i) You must have an Active Account which is in good standing with Crypto.com;
- (ii) You must not use your Crypto.com App account for commercial purposes;
- (iii) Both you and the Referred Customer(s) need to be at least 18 years of age and meet all requirements set forth in the Crypto.com App Terms and Conditions; and
- (iv) Both you and the Referred Customer need to be resident in an Eligible Region and registered as such in the Crypto.com App (as determined by Crypto.com in its sole and absolute discretion).

4 How the Offer Works

- **4.1. Share your Referral Code via the Crypto.com App or Approved Platforms.** The Referrer, a current customer of Crypto.com, shares their Referral Code through the Crypto.com App, via email, Facebook, Twitter or by any other means with a person, the Referred Customer, during the Campaign Period. There is no limit to the number of referrals you may make, however, certain restrictions may apply on a case by case basis. Where such restrictions are applicable, Referral Bonus(es) may be reverted at the sole discretion of Crypto.com.
- **4.2. Your Referral successfully registers.** Successful registration requires the provision of personal data by the person you shared your Referral Code with, as well as the successful completion of the Crypto.com App account verification procedure(s) during the Campaign Period. Inability, refusal, or delay to complete any of the required identification and/ or verification procedures may result in the Referral Bonus(es) not being credited. Successful completion of the Crypto.com App account verification procedures(s) shall be subject to Crypto.com confirmation, subject to its sole and absolute discretion.
- **4.3. Credit of Referral Bonus.** Referral Bonus is always credited in the fiat equivalent value of CRO, with any applicable exchange rates (such as USD/CRO) determined by Crypto.com in its sole and exclusive discretion, but generally for both the Referrer and the Referred Customer, upon the Referred Customer completing the staking process at the point when the staking of CRO for a Crypto.com Visa Card is performed.

Crypto.com reserves the right to change the Referral Bonus amount at its sole discretion at any time without any obligation on the part of Crypto.com to give notice to you. Crypto.com may also waive credited bonuses where it is determined that it has reasonable grounds to do so, even if all conditions set out above are met.

4.4. Competition Prizes. Referrers will be ranked in order of highest number of Referred Customers with an Active Account, and the top 50 Referrers (each, a "**Winner**"), as determined by Crypto.com in its sole discretion, will be eligible to receive a prize (each, a "**Prize**"), as set out below:

The Prize is offered and provided "as is" with no warranty or guarantee by Crypto.com or any affiliates entity, either express or implied. The Prize is non-negotiable, non-transferable and non-refundable, except that, in the event of unforeseen circumstances Crypto.com reserves the right to substitute the Prize for an alternative of equal or greater value. The Prize is exclusive of any tax, including, but not limited to, capital gains, income, sales, use, gross receipts, and ad valorem taxes, duties or similar charges that may be applicable to the Prize. The Winner shall be solely responsible for any such applicable taxes.

4.5. Winner Notification. Winners will be notified by Crypto.com within thirty (30) days of the end date of the Campaign Period using the email address associated with their Crypto.com App account. The Winner will need to provide to Crypto.com all relevant information and documents requested by the Crypto.com if necessary. A Winner who is not contactable or who fails to return contact, or provide necessary information to receive the Prize, within 48 hours will be disqualified, thereby forfeiting their right to the Prize, with no compensation given, and a reserve Referrer satisfying the eligibility criteria will be selected by Crypto.com on the same evaluative criteria as an alternative Winner. The Prize will be deposited into the Winners' Crypto.com App account within thirty (30) days of the end date of the Campaign Period. By accepting the Prize, a Winner agrees that they grant Crypto.com an exclusive, fully paid, royalty free, sub-licensable, transferable, perpetual, irrevocable, worldwide licence to submit, use and republish the details of their participation and rank. This includes sharing the Entrant's redacted name through social media and publication by Crypto.com worldwide in any of their publications, their websites and/or in any promotional material.

5 Retaining your Referral Bonus

- **5.1. Activity.** The Referred Customer(s) must maintain an Active Account for at least six months after the successful verification of the Crypto.com App account or until the end of the staking period, whichever comes later. Subject to these Terms, as well as any other circumstances which may occur from time to time, Crypto.com reserves the right, at its sole discretion, to classify as ineligible, and/ or retract any Referral Bonus(es) from, any Participant to the Offer.
- **5.2. Taxes.** Referral bonuses may be taxable, depending on the country, state, and/ or local tax laws applicable to the Participant. Participants are solely responsible for reporting such items in their tax returns and paying any associated tax(es) and liabilities.

- **5.3. Conduct.** Participants in the Offer must comply with all applicable national, federal, state and local laws, rules and regulations. 6 Prohibited Activities

The Referrer will not, and will ensure that the Referred Customer(s) do(es) not perform any of the following activities:

- (a) Create or operate multiple Crypto.com App accounts.
- (a) Make, in the sole but reasonable discretion of Crypto.com, misleading, illegal or ineligible transactions for the sole purpose of generating Referral Bonus(es).
- (b) Register Crypto.com App account(s) on behalf of a third party.
- (c) Allow any third parties to publish the Referrer's Referral Code on their websites, social media or disclose it in any other marketing materials by any other means.
- (d) Offer any additional incentives or rewards to the ones provided by the Offer to third parties to encourage them to apply for a Crypto.com App account.
- (e) Create or employ any mechanism(s) designed to generate Crypto.com App account registrations or populate the Referrer's Referral Code artificially or automatically.
- (f) Register a Crypto.com App account using counterfeit, forged, imitated, stolen, invalid or otherwise altered identification documents.
- (g) Use, create or publish any material related to Crypto.com that may be deemed offensive, hateful, threatening, harmful, graphically violent, harassing, or discriminatory.
- (h) Portray Crypto.com or its customers in any way that will have a detrimental impact on its or their reputation.
- (i) Artificially attempt to generate any Referral Bonus(es) by use of deception or misrepresentation.
- (j) Commit, or attempt to commit, any fraudulent activity.

(k) Make transactions that have no commercial purpose or are not for the personal benefit of the Crypto.com App account holder.

7 General Information

Crypto.com, at its sole discretion, may refrain from paying any Referral Bonus(es) or retract any previously credited Referral Bonus(es) by deducting or debiting the equivalent amount of the paid Referral Bonus(es) from your Crypto.com App account, where there are reasonable grounds to suspect that the Referrer or the Referred Customer(s) concerned:

i. is currently in possession of or has previously possessed another Crypto.com App account (either through a direct relationship or through a third-party) at the time of the Referral;

ii. has performed or attempted to perform any Prohibited Activity, as defined in Section 6 of these Terms; or

iii. is reasonably suspected to have been involved with illegal or abusive behavior and/or practices, and/or fraudulent activities or is otherwise in bad standing with Crypto.com.

8 Temporary or Permanent Closure of Referral Account

Referral Bonus(es) will be credited to the applicable Crypto.com App account(s). If the applicable Crypto.com App account(s) is/ are closed (whether permanently or temporarily) for any reason, Crypto.com will be unable to pay the Referral Bonus(es). Crypto.com will not be liable for the payment of Referral Bonus(es) to any Crypto.com App account(s) that were reopened after the initial attempt to credit the Referral Bonus(es).

9 Liability

- **9.1. Release**. By participating in the Offer, Participants release Crypto.com, its relevant parent company, subsidiaries, affiliates, suppliers, advertising, and promotions agencies and their respective directors, officers, employees, and agents from any and all liability arising from any loss, harm, damages, cost, or expense, including without limitation, any property damages, personal injury and/or death, arising out of or in any way connected to the Offer and/or the use of any Offer rewards (including, without limitation, the Referral Bonus and any Prize).
- **9.2. Indemnification**. - **9.3. Liability.** THE PARTIES AGREE THAT ANY CLAIMS AGAINST THE OTHER UNDER THESE TERMS MAY ONLY BE BROUGHT ON AN INDIVIDUAL BASIS AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS OR REPRESENTATIVE ACTION OR PROCEEDING.

NO COURT OR ADJUDICATOR MAY CONSOLIDATE OR JOIN MORE THAN ONE PERSON'S OR PARTY'S CLAIMS AND MAY NOT OTHERWISE PRESIDE OVER ANY FORM OF A CONSOLIDATED, REPRESENTATIVE, OR CLASS PROCEEDING. ANY RELIEF AWARDED TO ANY PARTICIPANT IN THE OFFER CANNOT AND MAY NOT AFFECT ANY OTHER PARTICIPANTS.

10 Termination

The Offer is only valid for referrals and registrations made during the Campaign Period. Crypto.com reserves the right to end the Offer at any time at its sole discretion without providing any prior notice.
