

Crypto.com Loaded Lions Merchandise

GIFT REDEMPTION TERMS

Crypto.com will conduct the Loaded Lion Hoodie distribution (the “**Award**”) substantially as described in these terms. By participating or receiving any Merchandise, each participant or recipient (“**Participant**”) agrees unconditionally to be bound by these terms (the “**Terms**”) and the decisions of Crypto.com, which are final and binding in all respects to the Award. Receiving any items from the Award (“**Merchandise**”) is contingent upon eligibility and fulfilling all requirements set forth herein.

1. Eligibility:

- The Award is only open to individuals that are hold a Loaded Lion NFT in their personal Crypto.com NFT Account at 00:00 UTC on the 12 September 2022 (the “**Snapshot Time**”) (“**Mane Netizens**”).
- Citizens and residents from Afghanistan, Bangladesh, Bolivia, Burma, Burundi, Central African Republic, China, Democratic Republic of Congo, Cuba, Ecuador, Eritrea, Guinea, Guinea-Bissau, Iran, Iraq, North Korea, Kyrgyzstan, Lebanon, Liberia, Libya, Mali, Namibia, Nepal, Russia, Somalia, Sudan, Syria, Ukraine, Venezuela, Yemen, Zimbabwe are not eligible for this gift redemption campaign.
- For the purposes of these Terms, a “**Crypto.com NFT Account**” means a Participant’s personal verified account on the Crypto.com NFT Platform at www.crypto.com/nft, which has successfully completed the applicable account opening procedures before the Snapshot Time. Crypto.com shall, in their sole and absolute discretion, decide whether or not a Participant’s account has completed the applicable account opening procedures.
- Entries submitted by persons who do not meet the above eligibility requirements are void.

2. How To Enter:

- Eligible Mane Netizens will receive a form, sent to their NFT Account Email Address, requesting them to enter their address and other necessary details (“**Entry**”). For the purposes of these Terms, a “**NFT Account Email Address**” is the email address associated with a Mane Netizen’s Crypto.com NFT Account.
- Participants must submit their Entry by 12:00 UTC on the 28th September 2022 (“**Claim End Date**”). Failure to submit the Entry by the Claim End Date shall be deemed to be a waiver by the individual Mane Netizen of their right to claim any Merchandise.
- Entries that are incomplete, corrupted, false, lost, late, misdirected, deceptive or otherwise not in compliance with the Terms may be disqualified from the Award at Crypto.com’s sole and absolute discretion. Any attempt by any person to enter the Award more than one (1) time by using multiple or different email addresses, identities, registrations and logins, or any other methods will void that Participant’s Entries and that Participant may be disqualified. Crypto.com and its affiliates, and their respective officers, directors, employees, contractors and agents (“**Crypto.com Affiliates and Persons**”) are not responsible for such void, invalid, voidable or disqualified entries. All Entries are the property of Crypto.com.
- Participants are eligible for one (1) Entry per Loaded Lion NFT owned. Participants will be eligible for the Cyber Cubs Booster (defined below) for every one (1) pair of Loaded Lion NFT and Cyber

Cubs NFT. Participants will be further eligible for the Pride Whales Booster (defined below) if they hold more than five (5) Loaded Lion NFTs and five (5) Cyber Cubs NFTs. A Participant can only be eligible for one (1) Pride Whale Booster. Participants will be eligible for the “**Cyber Cubs Booster**” for every pair of one (1) Loaded Lions NFT and one (1) Cyber Cubs NFT at the Snapshot Time. Participants will be eligible for the “**Pride Whale Booster**” if they own five (5) or more Loaded Lions and five (5) or more Cyber Cubs at the Snapshot Time.

3. Merchandise:

- The Merchandise will be a Loaded Lion Hoodie and (if applicable) a Cyber Cubs Booster and/or a Pride Whales Booster as specified by Crypto.com at the following blog post: [<https://crypto.com/product-news/loaded-lions-hoodie>].
- Crypto.com Affiliates and Persons shall have no responsibility or obligation to a Participant who is unable or unavailable to, or who does not for any reason, accept or utilise an item of Merchandise. Any costs, expenses, and taxes that may arise in relation to the Merchandise are solely Participant’s responsibility.
- THE MERCHANDISE IS OFFERED AND PROVIDED “AS IS” WITH NO WARRANTY OR GUARANTEE BY ANY CRYPTO.COM AFFILIATES AND PERSONS, EITHER EXPRESS OR IMPLIED (INCLUDING, BUT NOT LIMITED TO, ITS DELIVERY, CORRESPONDENCE TO ITS DESCRIPTION, SUITABILITY FOR A PARTICULAR PURPOSE, CONDITION AND QUALITY). Any Merchandise pictured in advertising and other Award materials are for illustrative purposes only.
- By receiving or accepting the hoodies, Participant agrees not to use or display the Merchandise in any way which is intended or reasonably likely to be considered to be offensive, harmful or illicit, or prejudicial, adverse or degrading to Crypto.com’s goodwill or reputation in the public.

4. Process

- All eligible Mane Netizens having successfully provided their details will receive the Merchandise to their specified address. Delivery times will vary due to location and the immediate circumstances of the Participant’s country.
- The Participant will receive an email confirmation once the Merchandise has been dispatched.
- Crypto.com shall have the sole and final decision regarding timekeeping for entry in the Giveaway.
- Crypto.com will not accept the return of Merchandise for refund, credit, exchange, or any other purpose.
- A Participant must provide Crypto.com with any information or certifications needed by Crypto.com, in its judgment. Without limiting the foregoing, a Participant may be required to sign a copy of these Terms, to complete and sign a Declaration of Compliance, Liability, and Publicity Release (except where prohibited by law), and provide any other document that Crypto.com determines is required, necessary or appropriate, in its judgment, to confirm the Participant’s eligibility and for tax reporting or other purposes. If the Participant fails to satisfy these conditions within a reasonable time (to be determined at Crypto.com’s sole and absolute discretion), that Participant will not be eligible for the Merchandise.

5. Privacy Terms:

- All information submitted by Participants and collected by Crypto.com in connection with your participation will be subject to and will be treated in a manner consistent with the Crypto.com Privacy Notice. By submitting an Entry, Participants agree that Crypto.com may collect and use his or her personal information submitted with the Entry, and acknowledges that they have read and accepted the Crypto.com Privacy Notice, available at: crypto.com/nft/privacy.html or otherwise provided to you within the Crypto.com App. Among other things, the information Participants provide may be used for sending Participants company updates and announcements about Crypto.com and its products and/or services.

6. Legal Terms:

- By participating in the Award or receiving any Merchandise, Participant agrees to indemnify, defend, and hold harmless, Crypto.com and Crypto.com Affiliates and Persons from any and all liability, for any claims, damages, injuries or losses of any kind, and to release all rights to bring any claim, action or proceeding arising out of, in connection with, or relating to participation in the Award.
- The value of the Merchandise may be taxable to the Participant as income. All federal, state and local tax liability, and any other costs and expenses associated with acceptance or use of the Merchandise not specifically provided for in these Terms are solely the Participant's responsibility (regardless of whether the Merchandise, in whole or in part, is used).
- Crypto.com Affiliates and Persons are not responsible if the Award cannot take place, or if the Merchandise cannot be awarded due to any events outside of the reasonable control of Crypto.com. If, for any reason the Award is not capable of running as planned, in Crypto.com's sole and absolute determination, Crypto.com reserves the right to cancel, terminate, modify, or suspend the Award or any part of the Award.
- ANY ATTEMPT BY ANY PERSON TO DELIBERATELY DAMAGE OR UNDERMINE THE LEGITIMATE OPERATION OF THE AWARD MAY BE IN VIOLATION OF CRIMINAL AND CIVIL LAW AND SHOULD SUCH AN ATTEMPT BE MADE, CRYPTO.COM RESERVES THE RIGHT TO SEEK REMEDIES AND DAMAGES (INCLUDING ATTORNEYS' FEES) FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW.
- In the event of any dispute, Crypto.com reserves the right to make all final decisions regarding the Award. Except where prohibited by law, Participant agrees that ANY DISPUTE, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATING TO THE AWARD SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION. These Terms are governed by and shall be construed and enforced under the laws of Hong Kong without regard to any choice or conflict of laws rules. If a dispute arises out of or relates to this Agreement, or the breach thereof, and if said dispute cannot be settled through negotiation it shall be finally resolved by binding arbitration administered by the Hong Kong International Arbitration Centre (HKIAC) under the HKIAC Administered Arbitration Rules in force when the Notice of Arbitration is submitted. The law of this arbitration clause shall be Hong Kong law. The seat of arbitration shall be in Hong Kong. The number of arbitrators shall be one, and judgment upon the award rendered by the arbitrators may be entered in any court having jurisdiction.

- Crypto.com reserves the right to cancel or amend the Award mechanics or Terms at any time at our sole discretion without prior notice to Participants.
