

Welcome, Mane Netizens!

We are launching the Loaded Lions Community Grant Program (“**Program**”) to empower the community to develop the Loaded Lions ecosystem.

These guidelines (“**Guidelines**”) are intended as a framework for all who are looking to apply to the Program. We want to foster a fair and transparent application process for all prospective applicants.

HOW TO APPLY

The Program is open to any individuals wishing to develop Loaded Lions utility, community or ecosystem (“**Participant(s)**”).

Proposals must be submitted via the applicable form at <https://bit.ly/3Th6kSR> (the “**Form**”) in accordance with all instructions and guidelines distributed by Crypto.com (“**Proposal(s)**”). Only Proposals satisfying the below requirements shall be considered eligible for the Program:

- (a) Thoroughly responding to each element of the Form, in Crypto.com’s sole and absolute discretion;
- (b) Meeting at least one of the following focus areas: (i) NFT utility development; (ii) gaming and metaverse; or (iii) community engagement, though Crypto.com reserves the right to consider Proposals which fail to fit into a focus area;
- (c) Capable of having a meaningful beneficial impact on the Loaded Lions community and brand;
- (d) Capable of having a significant impact within two (2) quarters of beginning development; and
- (e) Proposed by Participants who are each well-suited to deliver the Proposal.

By submitting your Proposal, you understand that you are entering the Program and agree to these Guidelines. Proposals in breach of or capable of breaching any part of these Guidelines, in Crypto.com’s sole and absolute discretion, shall be disqualified. Crypto.com reserves the right to exclude any Proposal from the Program at any time if they have any reason to believe that the Participant has breached or failed to satisfy any part of the Guidelines.

GRANT AWARD:

Successful Participants will receive a grant amount deemed proportionate to the Proposal, depending on the scope and need as outlined in the Form (“**Grant**”), and pursuant to a schedule deemed appropriate to incentivise reaching certain milestones, as determined by Crypto.com in its sole and absolute discretion.

SELECTION PROCEDURE

The Crypto.com Product Operations Team will screen through eligible Proposals to select those meeting the requirements set out in these Guidelines and any other official guidelines and instructions from Crypto.com (“**Qualifying Proposals**”). These Qualifying Proposals will be published in the dedicated channel of the Crypto.com Discord server (“**Server**”), and shall be open to Server members to upvote through emojis or other methods, as specified by Crypto.com in its sole discretion. In accordance with the thresholds and quora set out by Crypto.com, certain upvoted Qualifying Proposals

shall be shortlisted for further evaluation by a Loaded Lions Grant Committee. The Loaded Lions Grant Committee shall evaluate and select the shortlisted Qualifying Proposals as intended grant recipients (“**Recipients**”), subject to execution of a written agreement.

Recipients are not official and shall not be confirmed as such until they have provided the information and completed, signed and returned all documentation required by Crypto.com. If an intended Recipient cannot be contacted or cannot or will not sign and/or return the required documents or provide the information (including, without limitation, identity and know-your-customer information) requested in the time period set out by Crypto.com, the Participant will be ineligible to receive any Grant.

RESULTS

Crypto.com will endeavour to contact those Recipients having submitted a Qualifying Proposal, approved by both community vote and the Loaded Lions Grant Committee, via the email address provided in the Form as the point of contact, within thirty (30) days of the date of shortlisting of their Proposal. Any feedback is confidential information and may be subject to the Participant(s) signing a non-disclosure agreement.

At each stage of the selection procedure, Crypto.com may announce selected Participants and their Proposals on any Crypto.com social media platforms.

TERMS

In submitting a Proposal or Form, Participant represents and warrants that:

- they are at least eighteen (18) year of age at the time of submission;
- their Proposal does not and will not violate the rights of any third party, including without limitation, any contract, copyright, trademark, or other intellectual property right or any rights of privacy or publicity of any third-party.

In submitting a Proposal or Form, Participant acknowledges and agrees that:

- Any degrading, defamatory, fraudulent, graphic, hateful, profane, illegal, threatening, unethical or otherwise unacceptable behaviour, content or language; any harassment, promotion of suicide or self-harm, incitement of hate or violence, endorsement of hate groups, terrorism or criminal behaviour, spreading of false information; doxxing or submission of private information or of another’s work without their prior express approval; and misrepresentation as to another’s involvement and any impersonation of another person, brand or entity, shall result in your immediate disqualification, with or without notice, and Crypto.com reserves the right to take any other appropriate and/or corrective action;
- Copyright in all Proposals submitted for this Program remains with the respective Participants. However, Participants agree that by submitting a Proposal, they grant Crypto.com an exclusive, royalty free, perpetual, transferable, irrevocable, worldwide licence to use and republish their Proposal for any purpose. This includes sharing the Proposal through social media and publication by Crypto.com worldwide in any of their publications, their websites and/or in any promotional material. You agree that Crypto.com may cut, edit, use or arrange your Proposal as it deems appropriate, in its sole and absolute discretion;

The selection of a Qualifying Proposal does not entitle the Recipients to any Grant or support until all Recipients have provided the information and completed, signed and returned all documentation and contracts required by Crypto.com. If a Recipient fails to provide, complete, sign or return such information, documentation or contracts to Crypto.com in the time period set out by Crypto.com, the Recipient shall be ineligible to receive any Grant.
