

[Crypto.com](#) Onchain Wallet Limited Referral Campaign Terms and Conditions

1. Definitions

For the purposes of these Terms and Conditions:

- **Referral Campaign** means the campaign operated by Onchain Wallet Limited (“Onchain Wallet”, “we”, “us”, or “our”) that allows existing users to recommend the Onchain Wallet application to others.
- **Referrer** means an existing user of Onchain Wallet who participates in the Referral Campaign by referring new users.
- **Referred Customer** means an individual who is referred to Onchain Wallet by a Referrer and who successfully registers for a new Onchain Wallet account using the Referrer’s unique referral code or link.
- **Participant** means any Referrer or Referred Customer participating in the Referral Campaign.
- **Successful Referral** means a referral that meets all eligibility and process requirements as determined by Onchain Wallet in its sole discretion.

2. Eligibility

2.1. The Referral Campaign is open to individuals who have an active Onchain Wallet account and are not subject to any restrictions or prohibitions under applicable law, these terms and conditions, or the [Onchain Wallet Terms and Conditions](#) (together, the “**Terms**”).

2.2. Referred Customers must be new users who have not previously registered for an Onchain Wallet account.

2.3. The Referral Campaign is intended for personal and non-commercial use only. Marketing, posting, or promoting the Referral Campaign in public forums or to the general public is strictly prohibited.

3. Referral Process

3.1. Referrers may share their unique referral code or referral link with friends and family.

3.2. A Successful Referral occurs when a Referred Customer:

(a) registers for a new Onchain Wallet account using the Referrer’s unique referral code or link; and

(b) meets any additional requirements as specified by Onchain Wallet from time to time.

3.3. There is no limit to the number of referrals a Referrer may make, unless otherwise specified by Onchain Wallet.

4. Rewards and Incentives

4.1. No reward, remuneration, or incentive shall be given to Participants unless expressly specified by Onchain Wallet.

4.2. Any rewards or incentives, if offered, will be subject to additional terms and conditions as communicated by Onchain Wallet.

4.3. Onchain Wallet reserves the right to determine, in its sole discretion, whether a referral qualifies as a Successful Referral and whether any reward or incentive is due.

5. Limitations and Disqualification

5.1. Onchain Wallet reserves the right to disqualify any Participant, including any Referrer or Referred Customer, from participation in the Referral Campaign at any time and for any reason, including but not limited to suspected abuse, fraud, or violation of these Terms.

5.2. The Referral Campaign may not be used for commercial purposes or in any manner that is unlawful or prohibited by these Terms.

6. Termination and Changes

6.1. Onchain Wallet reserves the right to amend, suspend, or terminate the Referral Campaign, or any part thereof, at any time and for any reason, without prior notice.

6.2. Onchain Wallet's decisions regarding the Referral Campaign, including eligibility, rewards, and interpretation of these Terms, are final and binding.

7. Limitation of Liability

7.1. By participating in the Referral Campaign, Participants release Onchain Wallet, its affiliates, and their respective directors, officers, employees, and agents from any and all liability arising from or in connection with the Referral Campaign.

8. General

8.1. Participation in the Referral Campaign constitutes acceptance of these Terms.
