RULES FOR GIVEAWAY DRAW "TIGER CHAMPS"

ARTICLE 1 DEFINITIONS

1.1. The following terms (written with a capital letter, both in the singular and in the plural) shall have the following meanings:

"Account" means the account created by the User to use the Crypto.com NFT Platform, in the conditions laid down in the Crypto.com NFT Platform Terms and Conditions, as accessible at https://crypto.com/nft/terms.

"Buyer" means each buyer of a Sale Item on the Crypto.com NFT Platform.

"Contributors" means PARIS SAINT-GERMAIN and Jay Chou.

"Co-organizers" means PARIS SAINT-GERMAIN and Jay Chou, which are co-organizing the Giveaway Draw "TIGER CHAMPS"

"Crypto.com" means Foris Limited, a company incorporated in Hong Kong having its registered office at 1506-07, Pacific Plaza, 410 Des Voeux Road West, Hong Kong

"Crypto.com NFT Platform" means the NFT platform hosted on the Site, built and provided by Crypto.com or its affiliated entity to facilitate the transacting and display of NFTs including without limitation the importing, minting, sale and purchase of NFTs.

"Entrant": means each Buyer who is eligible to participate in Stage 1 and/or Stage 2 of the Giveaway Draw, according to conditions laid down in Article 3 of the Rules.

"Selected Entrant" means each Entrant who has been randomly selected during the Stage 2 of the Giveaway Draw, according to the Rules.

"Giveaway Draw" means the giveaway draw on the Crypto.com NFT Platform during which Crypto.com will, on behalf of the Co-organizers:

- 1) randomly determine the Sale Item allocated to each Entrant ("Stage 1");
- 2) organize six successive draws to randomly select Selected Entrants to whom a Giveaway Item will be awarded ("Stage 2").

"Owner" means the current owner of the Sale Item according to the Crypto.com NFT Platform. For the avoidance of doubt, is not considered as an Owner the Buyer who sold the Sale Item.

"NFT" means a non-fungible token.

"Sale Item(s)" means the digital original artworks created by Contributors to be sold on the Crypto.com NFT Platform minted as an NFT upon purchase by an Initial Buyer.

"Secondary Buyer": in respect of each Sale Item, the subsequent Owner who bought the Sale Item(s) to the Initial Buyer (or to any subsequent Owner) on the Crypto.com NFT Platform.

"Site" means the website https://crypto.com/nft/.

"Users" means individuals who have registered as end-users of the Crypto.com NFT Platform.

1.2. All other capitalized terms which are not expressly defined above shall have the same definition as the Crypto.com NFT Platform Terms and Conditions, as accessible at https://crypto.com/nft/terms.

ARTICLE 2 ORGANISING COMPANIES

The companies:

- PARIS SAINT-GERMAIN FOOTBALL, Limited Liability Professional Sports Company [Société Anonyme Sportive Professionnelle (SASP)], whose registered address is 24, rue du Commandant Guilbaud - 75016 PARIS, registered in the PARIS Trade and Companies Register under number B 382 357 721 (hereinafter the "Club" or "PARIS SAINT-GERMAIN");
- SAS JHB, a French société par actions simplifiée, the registered office of which is located at 4
 RUE PIERRE BLINE 21200 BEAUNE, registered with the French Registry of commerce and
 companies under number 841 483 647 RCS Dijon (hereinafter "Jay Chou"),

Hereinafter the "Co-organizers"

are co-organising a Giveaway Draw called "TIGER CHAMPS" (hereinafter the "Giveaway Draw"), in accordance with the terms and conditions described in these rules (hereinafter the "Rules").

ARTICLE 3 ELIGIBILITY

3.1. The Giveaway Draw is open exclusively to each Buyer who:

- (i) created an Account and purchased a Sale Item on the Crypto.com NFT Platform;
- (ii) is eighteen (18) years of age or older at the time of the purchase of the Sale Item;
- (iii) fulfils the Crypto.com NFT Platform Terms and Conditions, as accessible at https://crypto.com/nft/terms, as well as the laws, regulations and other texts in force in relation to such Giveaway Draw. Failure to comply with these conditions will invoke the invalidity of the entry in question;
- (iv) has an active e-mail account and Internet access and an access and login to the Account on the Crypto.com NFT Platform.

3.2. Conditions to participate in Stage 1 of the Giveaway Draw

Participation in the Stage 1 of the Giveaway Draw is open exclusively to each Initial Buyer who fulfils the conditions set out in Article 3.1. of these Rules. For the avoidance of doubt, the Secondary Buyers are not eligible to participate in the Stage 1 of the Giveaway Draw and will not benefit from the Ongoing Benefits.

Participation in the Stage 1 of the Giveaway Draw occurs automatically upon purchase of the Sale Item by the Initial Buyer on the Crypto.com NFT Platform.

3.3. Conditions to participate in the Stage 2 of the Giveaway Draw

Participation in the Stage 2 of the Giveaway Draw is open exclusively to each Buyer who fulfils the conditions set out in Article 3.1. of these Rules. By exception, the following are no longer eligible to participate in the Stage 2 of the Giveaway Draw:

- (i) the current Owner to whom a Giveaway Item has already been awarded during Stage 2 of the Giveaway Draw;
- (ii) the previous Owner who re-sold the Sale Item before the end of Stage 2 of the Giveaway Draw and without having been selected to receive a Giveaway Item.

Participation in the Stage 2 of the Giveaway Draw occurs automatically upon purchase of the Sale Item by a Buyer on the Crypto.com NFT Platform.

- **3.4.** Participation in the Giveaway Draw implies unreserved acceptance of the Rules. Failure to comply with the Rules will invoke the invalidity of the entry in question.
- **3.5.** The purchase of one Sale Item by an Entrant is equivalent to one participation in the Stage 1 and/or Stage 2 of the Giveaway Draw, it being specified that an Entrant is authorised to purchase up to ten (10) Sale Items.
- **3.6.** The Co-Organizers and Crypto.com reserve the right to ask any Entrant to provide proof of compliance of the conditions above. final and binding in all respects; (b) acknowledges compliance with these Rules; and (c) agrees to comply with any and all applicable federal, state and local laws, rules and regulations. GIVEAWAY DRAW IS VOID WHERE PROHIBITED.

Any transmission of false, incorrect or incomplete information will invoke the automatic cancellation of the entry.

Any disqualification or cancellation of participation will invoke the Ongoing Benefit and/or Giveaway Item to be reallocated.

The Entrants are informed in this regard that they must send the Co-organizers, if it requests as such, proof of identity and address in order to receive their Ongoing Benefits and /or Giveaway Item, as provided in Article 12 below.

Participation does not entitle the Entrant or Selected Entrant to any remuneration, right or advantage whatsoever, other than the allocation of the Ongoing Benefits and/or Giveaway Item, as defined in article 5 of the Rules.

ARTICLE 4 ORGANIZATION OF THE GIVEAWAY DRAW

4.1. The Giveaway Draw will consist of two stages:

1) Stage 1 - Allocation of Sale Items and Ongoing Benefits to each Entrant :

On the first date of the Sale Items drop of Jay Chou x PARIS SAINT-GERMAIN collection, 10,000 Sale Items will be put on sale at a unique price on the Crypto.com NFT Platform. These 10,000 Sale Items are divided into 3 (three) different categories of digital original artworks created by Contributors with traits of varying levels of rarity:

- 10 (ten) "Legendary" Sale Items
- 1970 (one thousand nine hundred and seventy) "Premium" Sale Items
- 8020 (eight thousand and twenty) "Basic" Sale Items

The category of the Sale Item allocated to each Entrant of Stage 1 of the Giveaway Draw will be determined randomly upon purchase of the Sale Item by the Entrant.

In addition to the Sale Items, and regardless of the Sale Item's category awarded to the Entrant, the purchase of one Sale Item by an Entrant of Stage 1 of the Giveaway Draw will give him /her access to the following Ongoing Benefits, which will be awarded by the Co-organizers:

(the "Ongoing Benefits")

The Ongoing Benefits will be awarded by the relevant Co-organizer to the person assigned to the mail address assigned to the Account of the Entrant of Stage 1 of the Giveaway Draw who purchased the Sale Item(s) on the Crypto.com NFT Platform or any other method specified by the Co-organizers. The identification of the Accounts of the Entrants of Stage 1 of the Giveaway Draw shall be verified by Crypto.com according to its method specified in its sole and exclusive discretion.

2) Stage 2 – Successive draws for the allocation of Giveaway Items to Selected Entrants

In addition to the Sale Items and the Ongoing Benefits, the Co-organizers will randomly select up to **524** (five hundred and twenty four) Owners to whom one of the following Giveaway Items will be randomly awarded:

In order to determine the Selected Entrants and the Giveaway Items to be awarded, Crypto.com will conduct 6 (six) successive draws on behalf of the Co-organizers, on dates and times chosen at Co-organizers own discretion, it being specified that all 6 (six) draws will be held during the calendar year 2022.

By exception to the eligibility conditions mentioned in Article 3.3 above, and for the first draw only, the previous Owner who re-sold the Sale Item before the date of the first draw remains eligible to participle in this first draw of the Stage 2 of the Giveaway Draw. The Giveaway Item will be awarded to the person assigned to the mail address assigned to the Selected Entrants' Account randomly selected from the Entrants of Stage 2 of the Giveaway Draw on the Crypto.com NFT Platform at the time of the relevant draw, according to the method specified by the Co-organizers, in their sole and exclusive discretion.

4.2. If for any reason a Giveaway Item and/or an Ongoing Benefit, or any part of the Giveaway Item and/or of the Ongoing Benefit, is unavailable or there is a delay in receiving the Giveaway Item and/or the Ongoing Benefit or a related event is delayed, cancelled or postponed, or for any other reason, the relevant Co-organizer or Crypto.com reserve the right to modify the Giveaway Item and/or the Ongoing Benefit in its sole discretion and award a substitute Giveaway Item and/or Ongoing Benefit, or portion of the Giveaway Item and/or of the Ongoing Benefit, of comparable or greater value as set forth in these Rules. No substitution, transfer, assignment or cash equivalent of the Giveaway Item and/or of the Ongoing Benefit, or any portion thereof, is permitted by the Entrant or Selected Entrant.

Co-organizers and Crypto.com shall have no responsibility or obligation to an Entrant or Selected Entrant who is unable or unavailable to, or who does not for any reason, accept or utilize the Giveaway Item. In the event a Selected Entrant cannot accept the Giveaway Item, an alternate Selected Entrant may be selected from all remaining Entrants of Stage 2 of the Giveaway Draw.
